THROUGH THE CASH POOL THE BANK IS THE LENDER. THE POSITIVE BALANCE OF THE UNIVERSITY ENABLES THIS PROVIDING A GUARANTEE (COLLATERAL) FOR THE LOANS BASED ON ITS CASH BALANCE.
